
The Head of the Departments in turn have conducted a curriculum meeting in their respective departments and suggested the possibilities in accordance with the demands of the stake holders.

A questionnaire was devised to collect the feedback from the students. Responses were recorded on a special five-point scale. 

**TEACHER FEEDBACK RESPONSE** 





# **EMPLOYERS' FEED BACK RESPONSE**





- **2.** Faculty guided the students to conduct research and which also received funding from reputed organizations.
- **3.** Scientific journal was restructured for the students to publish their research work.
- **4.** MOU's were signed with several institutions to facilitate the research.
- 5. Institution organized and encouraged attending several add-on courses

#### **5.NAME OF THE STAKEHOLDER: EMPLOYER**

A questionnaire was devised to collect the feedback from the professionals. Reponses were recorded using 4 options. The graph below shows the responses of the employers. 72% of the employers felt communication and attitude as excellent. 75% felt technical knowledge and skills were excellent. The quality and relevance of the curriculum to the chosen discipline was 87%. 90% employers felt the curriculum ensures professional ethics and attitude. 79% felt the curriculum enhance problem solving mentality and ability to innovate. 77% felt the overall impression about the organisation was excellent.



- 1. Playground facilities were made available to the students and support was provided in the institution and students are permitted to participate in various events organized by different establishments.
- 2. Library was provided with internet facilities and the timings are extended and several learning platforms are also included.
