Immunization requirements. All costs of student compliance with the immunization requirements will be the responsibility of the student. Immunization Requirements: Medical history form, which includes an immunization history, shall be given to all new students and must be completed and returned to office.

- All incoming students are required to provide to the satisfaction of student health;
- Immunization against Hepatitis B (compulsory vaccination at 0, 1 and 6month intervals in I BDS)
- Immunization compulsory by law or mandated by Lenora Institute of dental science will be waived under special circumstances.
- A student who objects to immunization upon the grounds that immunization conflicts with his or her valid religious beliefs and practices may request a religious waiver
- A waiver on religious grounds may be obtained by giving a written request to the principal.
- This waiver will not apply in case of any emergency or epidemic of disease which is declared by the Ministry of Health.
- Students requesting religious waiver should refer to this policy and contact the Principal for possible circular implications
