With reference to your letter 1st cited, the consent of affiliation issued by Dr.NTR University of Health Sciences for enhancement of seats in PG Degree Course in Dentistry (MDS) specified with number of seats as detailed in Form-3 is herewith enclosed.

It is further informed that this letter of consent does not confer any right to the management for granting affiliation by the University. This letter is issued only for fulfilling the qualifying criteria to apply to the Government of India / Dental Council of India for obtaining their permission to enhance the seats in PG Degree courses in Dentistry (MDS) at Lenora Institute of Dental Sciences, Rajamahendravaram.

When, once the Government of India permits, the said college shall apply for affiliation in the prescribed application form as per the statute on affiliation to the Dr. NTR University of Health Sciences, Vijayawada, A.P. giving all the details of facilities provided, for further scrutiny and consideration before actually starting of enhancement of PG Degree seats in Dentistry (MDS).


The management shall abide by the provisions of the University Act, Statutes on affiliation and ordinances of the Executive Council that are in force and that may be framed in future. Under any circumstances the management shall not admit the students before affiliation is granted for enhancement of seats in PG Degree course in Dentistry (MDS) by the Dr.NTR University of Health Sciences, Vijayawada. The management shall follow the conditions laid down:

1. Selection and admission of candidates shall be made as per the rules laid down by DCI, New Delhi / Govt. of India and State Government of AP/University.
2. The management shall follow the fee structure as prescribed by the Government of AP / University.
3. The management shall abide by the rules of the State Government, Statutes and rules of Dr.NTR University of Health Sciences, Vijayawada as may be framed from time to time.
4. After counseling starts for MDS course University will not include any new seats.

This letter of consent will be valid for a period of 2 (two) years from its date of issue and it implies that the college should start the course or to increase the admission capacity within 2 years. The University gives provisional affiliation after receiving permission from the Dental Council of India every year after due inspection.


